Eligibility

Any Fellow of the Society may be nominated for the Election of any of the posts other than the posts of Vice President cum President Elect, Honorary General Secretary, Honorary Treasurer and Honorary Editor, if his nomination is proposed and seconded by a Fellow, provided the Fellow has expressed his/her consent in writing to be nominated for the said post and has signed the Declaration in the Nomination Form.

The person nominated for the post of Vice President cum President Elect must be a Fellow of the Society for at least 10 years and must have served for at least one term as member of the Council.

The person nominated for the post of Honorary General Secretary must be a Fellow of the Society for at least 5 years and must have served for at least one term as member of the Council.

The person nominated for the post of Honorary Treasurer must be a Fellow of the Society for at least 5 years and must have served for at least one term as member of the Council.

The person nominated for the post of Honorary Editor must be a Fellow of the Society for at least 5 years and must have served for at least one term as member of the Council.

The nomination papers shall contain the signatures of Fellows who have paid their annual subscription for the current year before filing nominations. The OFFICIAL NOMINATION FORM is enclosed herewith.

The Nomination Form should be complete in all respects. Any blank entry in the forms shall render the NOMINATION invalid. The nominees should send a brief bio-data (not exceeding 100 words) along with photo with their nominations.

*Those fellows who have NOT cleared their dues for the year 2021-2022 cannot contest/nominate/propose/ second a Fellow member for the election and those nominations shall be held invalid.


